 - a. Comments (R. Gmeiner): Both classes are titled "interactive communication" and thus appear to be equivalent courses. If they are not equivalent courses, there should be a distinction in the title of the course. The solution presented will address issues of students taking the correct titled course for their major, but doesn't overcome issue with the course title being the same.
