1. COVID-19 Impacts-

- Expenses directly related to COVID-19 are being tracked for potential reimbursement.
- The University is eligible to receive \$6 million in the CARES Act. Approximately half of the eligible amount is for students and the other half for institutional use. A plan on how the University intends to disburse the funds must be submitted to the federal government within 30 days.
- The University intends to use a portion of the funds to cover extra expenses students may occur, for instance lab fees.
- A survey will be created for students to acknowledge they were impacted by COVID-19. The amount students receive will be based on their socioeconomic status indicated by the EFC on the student's FASFA. Dual enrolled students are ineligible. Students who do not submit a FASFA are still eligible and will be awarded appropriately. Students will receive \$500-1200 dollars
